## The U.P. Anatomy Rules, 1959

Notificaion No. 2037 (iii) A/V-507-57, dated April 3, 1959, Published in U.P. Gazette Pt. 1-A, dated 11th April, 1959, p. 712.

In exercise of the powers conferrd by Section 11 of the U.P. Anatomy Act, 1956 (U.P. Act No. VI of 1957) the Governor of Uttar Pradesh is pleased to make the following rules:

- 1.- In these rules, unless there is anything repugnant in the subject or context, -
  - (a) "Act" means the U.P. Anatomy Act, 1956;
  - (b) "Unclaimed dead body" means body of a deceased person, if such person has no relative, or if it is not claimed by any of his relatives, friends or servants within 48 hours of his death.
- **2.** Where the authority in charge of a medical institution requires unclaimed dead bodies for anatomical examination or dessection it shall send its requisition to the authorize officer by the end of June every year.
- **3.** The person intending to dedicate his dead body or the purpose of anatomical examination and dissection shall inform of his intention in writing to the authorized officer of the district concerned.
- **4.** Where an unclaimed dead body is not required by the authority in-charge of a medical institution for anatomical examination or dissection it shall be disposed of by the authorized officer in accordance with the provisions of paragraph 135-A of Police Regulation.
- **5.** (1) On reference made under Section 6 of the Act, an officer appointed thereunder by the State Government shall immediately fix a date for hearing within two days of the receipt of such reference and infrom the parties accrodingly.
- (2) After hearing the parties concerned, the officer, appointed by the State Government under Section 6 of the Act, may make such inquiry as he may think proper and fit to dispose of the case and shall give his decision on the date of hearing and his decision shall be final and conclusive.
- **6.** The authorized officer shall make arrangements for the preservation of unclaimed dead bodies in ice or mortuary cooler so as to preserve it from decay until -
  - (a) a decision has been taken under section 6; or
  - (b) it is handed over to his relative, friend or servant; or

(c) it is handed over to a medical institution for anatomical examination or dissection.
